CHAMBERSBURG STREET CONSTRUCTION SCHEDULED

Chambersburg, Franklin County – Please be advised that New Enterprise Stone & Lime Co., Inc. will soon begin construction work on the following streets:

1. Chopin Court (FDR)
2. Conner Avenue (Mill and Overlay)
3. Fifth Avenue (Lincoln Way East to Falling Spring Creek) (Mill and Overlay)
4. Girard Court (Ludwig Avenue to Washington Street) (FDR)
5. Harrison Avenue (Mill and Overlay)
6. Lincoln Road (Mill and Overlay)
7. East Ludwig Avenue (Mill and Overlay)
8. Monticello Court (Lincoln Way West to Loudon Street) (FDR)
9. Riddle Alley (FDR)
10. Virgo Court (FDR)
11. West Queen Street (Mill and Overlay)

The work, on several streets identified above with FDR, will involve Full Depth Reclamation, which recycles the existing asphalt to establish a base that is overlaid with an asphalt wearing course. Streets identified above with Mill and Overlay will involve removal of a layer of existing asphalt that is overlaid with an asphalt wearing course.

Construction activity will take place between 7:00 a.m. and 5:00 p.m., Monday through Friday.

Vehicle access on these streets will be restricted, with a New Enterprise Stone & Lime Co., Inc. flagging crew to properly direct vehicles through the construction site.

Parking will be prohibited at various times to allow the work to be done; however, Full Depth Reclamation creates a large amount of dust so vehicle owners are strongly encouraged to not park on the street at all while construction activity takes place.

Also, streets will remain open for local traffic only; however, they may be closed for short periods of time during certain phases of construction.

Due to unforeseen schedule changes due to weather, or other reasons, traffic cones will be placed along the curb prior to the start of construction activity, to include actual dates for construction activity to occur.

The Borough of Chambersburg and New Enterprise Stone & Lime Co. apologize in advance for this inconvenience and thank vehicle operators for your patience while street construction work takes place.

About Chambersburg:

Chambersburg is a unique community. Chambersburg supplies more services than any other municipality in the Commonwealth of Pennsylvania. In addition to typical town functions, Chambersburg is Pennsylvania's only municipality providing electric and gas to residents and businesses. Chambersburg is 1 of 35 Boroughs to operate a municipal non-profit electric utility. Chambersburg is the largest municipal electric utility in the State, twice as large as the second largest, Ephrata, Lancaster County; and, the only one to operate multiple generation stations. Chambersburg is 1 of 2 municipalities in PA to operate a natural gas utility. The other is Philadelphia, which does not operate an electric utility. Nationally, Chambersburg is 1 of 2,000 communities to have its own electric system and 1 of 1,000 communities to have a natural gas system but 1 of only about 60 to operate both. Chambersburg manages a regional water system, a regional sanitary sewer system (not through an independent Authority), and a new storm sewer utility; one of the first storm sewer utilities to form under the new Federal mandate to regulate stormwater. Chambersburg has a famous Aquatic Center as well. Chambersburg, the County Seat of Franklin County, currently has 22,172 residents (2022) and over 11,000 utility customers.
